#### AIS REGION 15 OCTOBER 12, 1991 GENERAL MEETING Hilton Hotel Ontario, CA

Inland President Joe Daugherty welcomed everyone and called the meeting to order at 10:35 AM. He introduced Fall Meeting Chairman Betty Cole, who after extending her welcome and offering a brief outline of the day's schedule, turned the meeting over to Regional Vice President Bobbie Shepard.

RVP Shepard asked for corrections or additions to the minutes as printed in the fall Newsletter. There being none, the minutes were approved as printed.

Treasurer Pete De Santis gave the treasurer's report. The Region General Fund has a balance of \$6,063.16 and the Regional Vice President's Fund has a balance of \$6,969.10 as of the date of this meeting. The treasurer's report was accepted and put into the record.

RVP Shepard reported on the results of the 1991 symposium for Region 15. She expressed her pleasure that 105 symposium ballots were voted this year in comparison to 63 ballots voted in 1990. She read the list of the 26 varieties which received at least 20 votes.

RVP Shepard reported that in their session held earlier today, the executive board had reviewed the Region 15 requirements for all levels of judges. Although changes were made, most requirements were approved without change and the entire package was approved as revised. Bill Rinehart, membership chair, will have these requirements printed for distribution to Region 15 members.

Bill Rinehart took the floor to express his delight at the turn out for the additional judges training session held the previous night (Friday night) and to thank everyone who attended the session for coming. RVP Shepard echoed Bill's remarks and asked the group for an expression of opinion regarding Region 15's holding judges training sessions on Friday night as well as Saturday morning at fall meetings. The new approach received a rousing round of applause.

RVP Shepard announced that the executive board has effected some changes to the rules and regulations which apply to the purchasing of Region 15 auction irises. One such change is that <u>only</u> tall bearded iris will be purchased for Region auction.

RVP Shepard announced that an invitation has been received from Region 20 to join a tri-state regional trek. A tri-state trek has been organized for this year with the idea that it could become an annual event between Colorado, New Mexico and Arizona (RVP Shepard thinks this should/could easily include the So. Cal. portion of Region 15 as well, although the original invitation was specifically aimed at the Arizona portion of Region 15). June 5 - 7 1992 are the dates set aside for this trek, which will be held in the Denver area. Information will be included in the Spring issue of the Region 15 Newsletter.

**RVP Shepard** called attention to the increase in AIS membership dues, which will be go into effect in January 1992. She recommended paying AIS dues in 1991 before they go up. Triennials are recommended.

**RVP Shepard** reminded everyone that Region 15 history books are still available for \$3.00.

Hazel Carson announced that the 1992 Spring Trek will take place on April 24 - 25 in San Deigo.

Ralph Strane will conduct a special Region 15 benefit raffle, which will include an iris patterned china service for eight, A.I.S. R & I books and other items to be added later. Ralph will accept any contributions, iris related or not, that someone might care to donate to the raffle.

RVP Shepard thanked outgoing Secretary Jeanne Plank and outgoing Treasurer Pete DeSantis for serving in these offices during the past three years. She then gve the floor to former RVP Ralph Strane, nominating committee chair for 1992. Ralph thanked his committee: Sarah Holk, Peggy Carpenter and Jim Day, with extra thanks to Sarah Holk.

The meeting was called to order by RVP Shepard. She thanked Joe Daugherty for the use of his home and hospitality then asked the board members to introduce themselves.

Minutes from the last meeting were read by outgoing secretary Jeanne Plank and were approved as read.

Bill Rinchart brought up a question regarding the changing of standing rules. A discussion followed. The Board was in agreement that the language in the standing rules should be clarified. This will be brought before the next general membership meeting.

Treasurer Pete De Santis handed out printed copes of the Treasurer's report. (Ed: A copy of that report is printed elsewhere in this newsletter.) As of January 1, 1992, the Region 15 General Fund checking and CD accounts total \$6,683.66 and the RVP Fund saving and CD accounts total \$7,058.27.

Following a discussion on where to have Region 15 money invested for the best income return, it was decided to delay any action until the new Treas- urer was able to take office. Cal Boswick, incoming Treasurer, has been unable to assume the duties of Treasurer due to the grave illness of his wife.

Joe Daugherty moved, Jeanne Plank seconded that Pete De Santis continue to act as Treasurer until Cal Boswick can take over, or until the Spring Meeting at which time the office would be declared vacant and the election of a new treasurer would be held. Motion carried.

Gene Strawn moved, Jeanne Plank seconded that acting Treasurer Pete De Santis be instructed to roll over the CD for another ninety days when it matures in February. Motion carried.

RVP Shepard gave her report on the AIS Director's Fall meeting held in Indianapolis, IN. She reported that there were more RVP's present at this year's meeting than ever before. She sees no serious problems ahead for achieving the goal of getting voting representation for RVP's on the AIS Board of Directors.

Very special news brought back from Indianapolis by RVP Shepard is that Region 15 hybridizer Bernard Hamner has been awarded the Hybridizers Medal for 1991.

RVP Shepard announced that the 1939 checklist has been reprinted in paperback, is selling for \$10.00 and can be purchased through AIS Publications.

Bill Rinehart passed out printed copies of judges training requirements. A discussion followed on the AIS rules on judging. Bill announced that Region 15 has 14 student judges; 2 apprentice judges, 36 accredited judges, 11 active master judges; 10 retired master judges; and 3 emeritus judges. RVP Shepard asked Bill to mail training requirements to all judges.

RVP Shepard handed out Region 15 AIS membership lists to club representatives along with Application for Affiliation forms which need to be filled out and returned by the end of January.

Vickie Day is retiring as editor of the Region 15 Newsletter. Jeanne Plank has agreed to edit the newsletter for <u>one year</u>.

Hazel Carson gave the report from SDICIS on the Spring Trek. Ralph Strane will have an article in the spring Newsletter on the Region 15 raffle to be held at the Spring Trek. Bill Rinehart discussed the possibility of having progressive judges training in the gardens during the Spring Trek. Information on this will be distributed at a later date through the local clubs.

RVP Shepard brought up the problem of setting up a schedule for fall and spring regional meetings. After much discussion a tentative schedule was put together to be sent to Region clubs for their approval. (Ed: The proposed Regional meeting schedule maybe found printed elsewhere in this newsletter.)

Meeting adjourned for lunch.

The meeting was called to order at 1:00 PM. Ralph Strame was thanked for the really fine lunch of chicken breasts in sauce, rice pilaf, vegetables, salad and a dessert of warm persimmon pudding with lemon sauce that he cooked and served.

It was announced that Monty Byers passed away the Monday before Christmas.

RVP Shepard announced that in her 20 years of attending Fall Meetings, this past Fall Meeting was by far the nicest one she has ever attended. We all agreed with her that the Inland Iris Society chairperson and crew did an outstanding job.

Pete De Santis presented the AIS Region 15, 1992 proposed budget. (Ed: 1992 Proposed Budget is printed along with 1/11/92 Treasurer's report elsewhere in this Newsletter.)

Jeanne Plank moved, Joe Daugherty seconded that the budget be accepted as proposed. Motion carried.

Pete De Santis recommended that club presidents encourage their members to participate in the Region Auction since, right now, this is the only source for Region income. He also recommended that societies start the bidding at half catalog price when auctioning region irises.

RVP Shepard discussed having a boutique for Region 15 fund raising at spring and fall regional meetings.

Pete De Santis presented SDICIS President Hazel Carson with a check for \$150.00 from Region 15 to help defray the costs of the '92 spring Trek.

RVP Shepard asked that following adjournment, club presidents meet together in one room while committee chairmen convene in another to exchange ideas and to discuss special interests, needs and problems more efficiently.

The meeting was adjourned.

#### SAN DIEGO & IMPERIAL COUNTIES IRIS SOCIETY

In November we had a man tell us about a liquid product that is diluted, sprayed on the ground, and watered in well. This product, called *Desert Bloom*, works for one year to keep evaporation down to where you only water half as often. It biodegrades in three years.

On December 6 and 7 the City's "Christmas on the Prado" was held in Balboa Park. Our iris society was one of twenty organizations who decorated a Christmas tree indoors for the occasion. On Sunday, December 15 we held our Annual Christmas Party at the home of Bill and Claire Barr. The weather was lovely. We had a wonderful time in their delightful home sharing a Christmas potluck, exchanging gifts, and visiting with each other.

Our January speaker was called out of town so very quick-like we called to the State of Virginia and had slides of rebloomers sent to us. Two years ago when John Weiler showed slides and spoke on rebloomers, our own Fred Higginbottom brought several varieties from him. Fred kept a good record of the times they bloomed. Out of 50 irises, 38 bloomed consistently 2, 3, or 4 times a year. We enjoyed hearing of his experiences with them. He shared many rhizomes with us, enough for everyone to take home a door prize. The slides from the AIS covered arilbreds and the wee little ones all the way up to the tall bearded and we enjoyed them very much.

In February we have our yearly birthday party. It will be held the third Saturday at the Seven Seas in Mission Valley. We are looking forward to Herb Holk's talk.

March brings Ralph Strane to us to share his thoughts on preparing for a show. He will be bringing some of the items to be raffled at the Spring Trek, to tempt us.

April is the time for us to wish for plenty of sunshine and rain for lots and lots of bloom for the Region 15 Spring Trek. We hope to see many of our Irisarians there.

On May 2 - 3 we'll have our iris show in Room 101 in Balboa Park. We're planning on selling iris rhizomes at the show.

#### SPRING TREK, REGION 15 FUND RAISING RAFFLE

Region 15 will conduct a raffle at the 1992 Spring Trek.

The proceeds from the raffle will help with keeping the RVP Travel Fund from eroding away. Each year the Region does what it can to maintain the RVP Travel Fund by adding to it whatever year-end surplus funds may be available from the General Fund account. Much of what can be done depends upon the generosity of the local clubs when they account for their Region rhizome sale/donation. Traditionally these sales/donations are the sole source of operating funds for the Region. When Region rhizome sales/donations are lean, the funds available for operating are lean and the RVP Travel fund gets leaner since Travel Fund money is used each year and is not nurtured during lean years by any surplus from the General Fund.

Travel Fund money is a separate account to be used only to assist the RVP with the costs of traveling to and from the AIS Board of Directors meetings held twice a year. Vote representation for the RVP's on the AIS Board of Directors has been difficult to achieve, but it is about to happen. Because of this, it is more important now than ever before to have our RVP present at <u>both</u> of the AIS National meetings. This fund raising Region Raffle will help us to continue to send our RVP's to these important AIS meetings.

Separate tickets may be purchased for each of the items to be raffled. The person buying the raffle ticket(s) will have the option of dropping his ticket(s) into a box which will be placed in front of the item(s) of his choice. You need not run the risk winning something you do not now, nor ever would want.

Tickets will be on sale at raffle table.

#### SOUTHERN CALIFORNIA IRIS SOCIETY

#### **DESCANSO GARDENS**

Descanso will celebrate its fifth bloom season in 1992. We now have well over 900 named cultivars in all classes of iris (except MDB's) as well as a modest number of species growing in our display beds. The Iris garden has become an important visitor attraction at Descanso in the spring.

Every plant in the iris garden will be receiving a new label before spring bloom. The long range durablity of these new labels is still unproven, so we will need to pay close attention to their ability to stand up under garden conditions. The new labeling process has many advantages over the process used in the past, and the greater legibility & clarity of the print should make it easier for the garden visitor to take and make note of things he/she likes.

You are invited to visit Descanso this spring, if at all possible. Dynamic plans are in motion which will dramatically affect the iris garden. Next year, if things proceed according to plan, it is possible that the iris garden, in conjunction with the Descanso's "World Class Rose Garden" project, will be undergoing major rennovation and redesign. This million dollar plus project is proposed to begin construction in the fall of '92, but will probably not reach completion until '94. Spring of '92 could be the last opportunity for a couple of years to see significant bloom in the Descanso iris and rose gardens. The new iris garden will still be in the same general area in which it is now located; however, the actual space available for iris plants will be larger than the current 4,000 plus sq.ft.. The lay-out of the bed area will be different and, wisely, the individual beds will be smaller, which makes for easier viewing as well as general grooming and care. Those of us who spend our Descanso volunteer hours in the iris area are excited and happy about this new design.

Descanso puts on an annual Spring Flower Show, which has long been widely acclaimed for its beautiful Spring bulb display (forty thousand tulips, daffodils and crocus). Currently, it is the only major flower show in the LA area. This year the Descanso Gardens Spring Flower Show will run from March 21st through April 19th, with a three day "in-garden" plant sale taking place on the weekend of April 10 -12.

Spring bloom in the Descanso iris garden generally starts a little before the middle of March and runs past the middle of May with peak bloom coming about or before the 1st of May. Keep in mind that during the time when the iris garden is reaching peak bloom, following the official closing dates for the Spring Flower Show, much of that spring display throughout Descanso will still be there to enjoy. You are urged to visit the gardens often during this period if you can. One other note. The third Tuesday of each month is "free admission day" at Descanso. During this year's iris bloom time, that date will be Tuesday, April 21.

#### A TRIBUTE TO MELBA HAMBLEN Infinite Grace

Mona Boswick died on January 16, 1992 I met my wife, Mona Boswick, 47 years ago. We were married in April 1949, 44 years ago. It was not long after that she interested me in iris.

She was very knowledgeable about iris and had a green thumbthe, She grew them even in Manhattan Beach, where we lived near the ocean and iris really didn't like all the fog - much preferring sunshine.

We moved to the valley in 1951 and her iris display garden soon became a five acre commercial iris garden which we operated for about ten years.

Mona and I often talked about the need to have an iris club in this area and we did a lot of planning about making this a reality. But her health began to fail and she coould no longer work in the garden anymore. Then her eyesight failed her too. For a time it looked like our dream of having a club here would have to be forgotten. But just at this crucial moment, Beulah Robinson arrived from Seattle and she wanted to see the development of iris here too. Beulah and I put our heads together and with the encouragement and support I received from Mona, Hi-Desert Iris Society was born. Although Mona was only able to attend one meeting of the organization Beulah and I put together, she was one of the first three charter members of the club and was a dues paying member to the end.

In addition to our club, she has been a member of the American Iris Society, except for a couple of years in the 1970s, continuously since 1952. In addition to our club, she also had been a long time member of the Southern California Iris Society.

I will miss my wife dearly and the iris world has lost a true blooded Irisarian.

The skies of irisdom are a little less bright as a star has dimmed with the passing of Melba Hamblen on January 17, 1992 in Roy, Utah.

Winner of the Hybridizer's Medal (1961), The Distinguished Service Medal (1973), the Foster Memorial Plaque (1981), and co-author of <u>The</u> <u>World Of Irises</u>, Melba was a friend and inspiration to all who shared her love of iris.

Her introductions spanned a period of over 35 years, and she will always be remembered for varieties such as GLITTERING AMBER ('57), ORANGE PARADE ('61), LILAC CHAMPAIGN ('65), CHARMAINE ('67) which were among her early string of successes, as well as for the newer LOVELY KAY ('80), SUNSET SONATA ('80), RON ('81), CAPRICIOUS ('81) RUFFLES AND LACE ('82) AND EXTRAVAGANT ('83). Melba won many AMs and EXTRAVGANT was runner-up for the Dykes Medal in 1991.

Melba was a pioneer with her crosses of blue iris with pink iris which added the tangerine factor to blue iris lines with ENCHANTED VIOLET ('58), VALIMAR ('58) and FASHION SHOW ('59)

Many notable bicolors were among her introduction, some of which are BETTY SIMON ('76), HEAVENLY HARMONY ('78), SUGARPLUM FAIRY ('80), INFINITE GRACE ('81), FRANCES GAULTER ('83), AND KAREN ('84). A particular favorite of Melba's were the burnt sienna and henna colored beards as seen in DANCE AWAY ('88) AND ADVENTURESS ('85).

One goal on which Melba was working was to get a blue bearded pink iris. Progress was being made with SOPHISTICATION ('84) and GIFT OF DREAMS ('87). These iris brought her full circle back to those first tangerine bearded violet-blue irises of many, many years ago.
