

ANNUAL PRESIDENTIAL LETTER

The American Iris Society

July 24, 1996

Each year the terms of office expire for one-third of the twelve directors of The American Iris Society, and four are elected to fill those positions. As provided in the AIS bylaws, a five member Personnel Committee recommends to the AIS Board of Directors candidates for nomination as directors. The Personnel Committee consists of two directors chosen from the Board of Directors, two RVPs elected by the Board of Counselors and one Section member elected by the Section Advisory Board.

Approved during the 1996 spring meeting held in Sacramento, California in accordance with the AIS bylaws, the four nominees for regular three year terms expiring in 1999 are:

Michael Moller Mike Lowe Shirley Pope Riley Probst

The bylaws provide that nominations may be made by any forty members of whom not more than fifteen may be located in any one region. Such additional nominations must be received by the AIS Secretary on or before September 1, 1996. Should additional nominations be made, a ballot on which all nominees are listed will be mailed on or before October 1, 1996 to all AIS members and must be received by the AIS Secretary, or Election Committee (if one is appointed) on or before November 1, 1996. If there are no nominations in addition to those listed above, issuance of a ballot may be omitted. It is imperative you act quickly in this important notification of the membership.

RVP Message

It is true that time flies by when you are having fun. It is also true that time accelerates as one ages. When you are old and having as much fun as conditions permit, three years go quickly even though you don't. Be that as it may, Region 15 is looking good and the membership can be justifiably proud of themselves. I want to reassure each and every contributing member, that I note and appreciate your support and your service. However, rather than submit the usual "freebie" end of term message of itemized thank yous, I would ask you to accept my generic and no less sincere gratitude so that I may deliver one last sermon.

Two Region 15 affiliates held local club auctions in the last 10 days. The chairs were each provided a budget of \$500-\$600 from affiliate treasuries with which to conduct the event. Thirty four members attended Thursday night. Twenty seven members were present Saturday afternoon. The Thursday evening auction realized a gross of \$2000+; the bidding Saturday afternoon grossed \$600+. It is interesting, but probably not significant, that the less successful affiliate set appreciably higher minimum bids. Other differences in marketing could be observed, but the contributory factors to the greater profit become apparent with additional information.

The merchandise list for the Thursday night auction reveals the following: 206 rhizomes introduced no earlier than 1993 were available. 15 of these rhizomes were purchased from affiliate funds and generated 54 extras.

Therefore, 19 members donated 135 rhizomes meeting the same standards of recency as above. The Saturday hosts auctioned approximately 100 rhizomes all purchases or extras. Dates of introduction ranged from 1990- 96 with the majority of the items in the early '90s by design.

To repeat 19 members donated 135 rhizomes. I hear your comments, "Not in my club," or "Not in my Region." Why not???!!! Members have been picking up newer introductions at a fraction of catalog prices at such auctions for a number of years. In many such auctions only members may participate. Even the most virulent-thumbed irisarian should be able to prize an appropriate rhizome or two out of surviving clumps. If even a small percentage of a membership contributes pure profit rhizomes the gross and net surges proportionately.

But that response does not speak to a major

problem which is that affiliates have been pandering to members who contribute rhizomes to auctions or sales: paying contributors a set amount for each rhizome donated or a percentage of the amount realized on each rhizome sold. Such policies are self-defeating. The affiliates most involved in this kind of behavior are having the most difficulty making a profit from fund raisers, balancing a budget, going without chairs for necessary tasks etc. and having interpersonal problems among members. A given is that the cost of bribery continually increases.

Clubs so infiltrated must wrestle with the connotations of the paragraph above on their own. Neither of the auctions cited above were operated under those circumstances. Most affiliates in this region mirror the less successful experience. Local auctions are not making the expected dollars, expenses are exceeding income and anxiety is afoot and horseback. The readily available excuse for this condition is that the successful region auctions compete with the affiliate auctions.

As a consequence, the region is reluctantly anticipating diminished support this year: two affiliates regularly hosting region 15 auctions chose not to do so, fortunately one of these has changed this position; a 3rd affiliate has asked that the number of rhizomes supplied them for auction be cut drastically, a 4th affiliate has not hosted a region auction in 8 years.

I understand the competition argument, but having conducted affiliate and/or region auctions since 1976 I know it just aint so unless you make the unprintable mistake of holding both auctions at Attendance at auctions will the same meeting! always be below the average attendance at "regular" meetings. Auctions are not spectator sports. But the attendance for auctions will remain constant whether you conduct 1 auction or 2. Granted that bidders may have a budget for new rhizomes. Bidders who have expended that budget at the first auction seem to scrape up a "bankroll" for succeeding auctions. How many of you attend 1 garage sale a year, or 1 department store sale a year?. If there is a bargain to be had on an item you think you need, you'll be there. Auctions provide such bargains.

If affiliate leaders accept the above, then they now realize that the only expense they may incur is the rental of the meeting site. And that is not a necessary expense. Auctions have been held successfully in parks, or members homes or grounds. Rhizomes auctioned for the region are the guests iris from the spring meeting that donors have released for that purpose. Nobody has to my knowledge ever been asked to guarantee an attendance figure or a financial return. The profits come from the voluntary actions of individuals, not representatives of affiliates as such.

Editor's Notes

Well you may have noticed that we have changed the format of the Newsletter. This is partially because of new changes required by the USPS (United States Postal Service). To qualify for the cheaper bulk rates offered by USPS we have to change to a letter size page, thus our new layout. Our previous bulletins were printed on legal size pages. The letter size page makes the layout for a booklet style newsletter much more difficult and time consuming for me to manage.

DID I ORDER ALL THESE? BUT IT'S 110 °IN THE SHADE!

Last spring, when the iris were in bloom and all those catalogs arrived it was easy to imagine an even larger garden with still more iris. We read the descriptions, made out our orders, wrote our checks, and sent them on their way. And the mid-May weather was beautifully pleasant.

Now those iris have begun to arrive. With each approach of the UPS truck we wonder, "Did I order all THESE?" And on top of the ones we ordered are the gift extras that the gardens so generously include sometimes as many as the original order.

But now they're here, the weather isn't so nice, it's over 90°, the ground is too dry and hard to dig, and we're leaving for a vacation trip tomorrow anyway. What to do?

If conditions aren't right for planting iris on the day they are delivered, there are several things one can do.

All bearded iris - TB, MTB, IB, BB, SDB, MDB, arilbred - will survive even if they aren't planted for some time. (Of course, the sooner they get started growing the more likely they will produce bloomstalks next spring.) If immediate planting is out of the question, open the box, remove the packing material, and place the open box in a dark cool (but not damp) place until planting time.

Better than letting them sit unplanted would be to get them into soil so they can begin to put out roots. If you still haven't dug up the section of everdecreasing lawn where the new bed will be, consider this: Plant them in clay pots. Working out of the sun, mix a healthy combination of garden soil, top soil, peat (none of this for arilbreds), and sand. Then plant one rhizome per pot, selecting one large enough to allow the roots to expand. This way, growth gets underway without delay until the final site is prepared. Such potted plants can continue like this for several weeks.

When planting time comes, all you need do is prepare a hole, knock out the iris and its pot of soil (You'll be amazed how soon the pot becomes filled with roots), and set it in place with a minimum of disturbance.

This method has been found to eliminate winter heaving because the roots are already well anchored before they're placed in the garden.

If you're receiving any of the beardless iris - Siberians, Louisianas, Japanese, pseudacorus, et cetera the same approach can be used with only slight modifications.

These iris are usually shipped in plastic bags to retain moisture en route and the important thing to remember is that they MUST NOT BE ALLOWED TO DRY OUT.

Thus, plastic pots are better than clay because they retain moisture better. The potting mixture for these iris should include more peat and some composted manure. Daily watering will be necessary. Or, if you are leaving for vacation, these pots can be stood in shallow pans of water (Adolph Vogt uses plastic wading pools). In fact, the Japanese and Louisianas can be left growing in standing water right up until cold weather.

Most iris are pretty hardy plants. They want to survive. Giving them this planting-season advantage will be rewarded when you see them in bloom next spring.

BUSINESS:

Affiliation: RVP Rinehart distributed the AIS Affiliate Receipts to the club presidents for their files.

Awards: It was MOVED, SECONDED and CARRIED to approve purchase of the Claire Barr Award trophies for \$82.50, 1st trophy, \$62.50 for 9 consecutive trophies for a total of \$676.56 (incl tax). It was generally agreed not to "require" Affiliates to purchase these trophies, but any such donation purchases will be greatly accepted. The awards to be given at the Spring '96 Trek were reviewed, as well as the ballot use and collection and counting procedures. It was agreed to allow Claire Barr to present the first of the new trophy bearing her name to the winner at the Trek.

Judges Training: Chairman Herb Holk distributed a new Judges Activity Report form and noted all future updates to these forms will bear a revision date at the bottom. New questions have been added to this form, to be dated "4/96" (Exhibit B) regarding attendance at Treks and Conventions, voting both the Symposium and Ballot, and entering and reviewing shows, as well as voting for HCs or ECs

Chairman Holk stressed the important requirement that all Region 15 Judges Training Programs must receive prior approval by the Judges Training Chairman, that all Judges attending such sessions must take the test to receive credit, and must sign the attendance sheet. The attendance sheet must be forwarded to the Judges Training Chair within 2 weeks of the program. Noting that all Judges should have received their AIS Ballots by now, Chairman Holk strongly urged them not to put off this important requirement, but to vote at once. He further stressed that Judges and Students visit as many iris gardens as they

possibly can (in addition to Trek and Convention gardens) during the bloom season.

Membership:

Chairman Sara Holk distributed the Region 15 AIS Membership Report (Exhibit C), as well as a list of additions and corrections to the AIS Region 15 membership roster (Exhibit D). She said our region is now the 5th largest in AIS Membership. In regard to AIS eliminating mid-year (July) memberships, those who join before September will be considered an AIS member for the current year. Those joining from October on, will become AIS members the following January.

<u>Newsletter:</u> Editor Giles said June 1st is the deadline for the next Region 15 Bulletin. RVP Rinehart said he will send copies of all the Show Reports to Giles as he receives them, at the same time urging club's not be late with their reports.

Nomination of Officers: Chairman DeSantis said his committee will present a firm slate of officers at the October 1996 meeting, in addition to the Fall Newsletter. It was MOVED that the Assistant RVP position be required to also be the Judges Training Chair, but the motion died for lack of a Second.

Region Auctions: RVP Rinehart reminded the club presidents that at our January meeting it was agreed that they would schedule their Region Auction dates in September rather than August as in the past. TAIS President Barnhill will contact the club presidents after the Trek to determine the club Auction dates as well as preference in regard to type of iris wanted. RVP Rinehart said he would be willing to serve as auctioneer for any of the clubs that wished him to do so. The San Diego club said they only wanted 1/2 the normal shipment of Auction rhizomes, and Southern California and Orange County do not want any.

<u>Symposium:</u> RVP Rinehart once again urged the club presidents to remind their AIS members to vote the Symposium Ballot of favorite irises. Last year we were only 1 vote short of having the most votes of any Region.

Region Meetings: The Fall 1996 meeting will be hosted by the San Diego & Imperial County Iris Society and will be held at the Hanali Hotel in Mission Viejo, CA on October 12th (one-day). Hooker Nichols will be the Luncheon Keynote Speaker as well as give the Judges Training Program. The 1998 Spring Trek will be hosted by the Sun Country Iris Society, Bobbie Shepard cochairing with Ellen Smith. RVP Rinehart noted that Region 14 had issued an invitation to our members to attend their Fall Meeting in Las Vegas, NV on October 26 as well.

<u>ADJOURNMENT:</u> The meeting was adjourned at 2:40 pm.
